Review and Accept Minutes of December 21, 2023: Robert Gargano made a motion to accept the minutes as presented which received a second from Mike Waddell. The Clerk informed the board that Abby Evankow had emailed with a recommendation to amend the minutes to reflect the discussion regarding the lighting of the flag at the Mom's location by adding the following: "Brian Ruel said that the Milton Rents flag is illuminated 24 hours but the light faces down instead of up. MOM's might be approached to have a similar down facing light, so as to help preserve our Dark Skies". Public Hearing for Case #13-2023 (Continued)

Steven Heyliger explained to the board that one of the items that was an outstanding question as part of the property lines was a culvert that runs underneath the property. He researched and found a prior owner (Armand Patenaude) had conveyed an easement to the NH DOT to allow the culvert to pass from Main Street through the property coming out of the embankment at the rear of the property. He supplied the deed indicating that easement. Robert Gargano wanted to recognize Mr. Croteau's efforts to clean up the site. Dennis Pednault brought up the neighbors to this property are using the property without town permission. Mike Waddell noted that this survey identified that issue and this is something that will need to be looked at in the future. He

felt that a fence at this time is appropriate at this site. Mr. Croteau asked if he could use the town property for customer parking. Tara Bamford presented the board with a draft Notice of Decision which she drafted with input from the Town attorney. The board went through the Draft NOD and made several changes.
